Comply with all rules and regulations. Taking shortcuts can come back to bite a business owner if someone suing you can prove you have been negligent or have acted fraudulently.

Have the right insurance. If you own your own business as well as the building that houses your company, you will need to have different insurance policies for both. Having the right kind of business insurance makes your own personal wealth less of a target in case of a business lawsuit.
